The City and County of San Francisco's Department of Early Childhood (DEC) funds early education and child care programs, including the one that your child/children attend(s). To receive this funding, the program is required to collect and share the below information with the City and County of San Francisco on all children participating in the program. Although you may be asked to provide other optional data, the list below shows the data that are required as part of your child/children's enrollment at this site:

- Your child's name, date of birth, race/ethnicity, and home language
- The parent/guardian name and home address or homeless/unhoused status
- The parent/guardian phone number and email address
- The program your child attends, and when your child started and finished the program
- Other funding that supports your child's program (state funding, federal funding, etc.)
- If your child has special needs and, if so, what types of special needs
- Whether your child is at risk of abuse or neglect (CPS)
- Your family size and income level
- Your child's Ages and Stages Questionnaire (ASQ) developmental screening dates and results
- The dates of your child's Desired Results Developmental Profile (DRDP) assessments and parentteacher conferences

By enrolling at this site, which receives DEC funding, your child may be given the benefit of arts and literacy enrichment, health and dental screening, and developmental screening and intervention, and the site and its staff members may receive higher wages and benefits, coaching, and mental health consultation. These services are intended to improve the quality of the program and to support your child's learning. As part of enrollment, you are agreeing to share your child's data with DEC and the partners that provide these services, maintain DEC data systems, and evaluate DEC programs and services. This information is not shared externally beyond the City and County and its partners except with your written consent.

Our data policy is **NOT TO SHARE** information with private corporations or marketing firms, or collection and credit agencies. We also **WILL NOT SHARE** your data with criminal justice, family courts, Immigration and Customs Enforcement, IRS, DMV, unless given a specific legal mandate to do so. This information helps to improve services and inform the public how DEC supports early care and education in San Francisco. Your individual identifying information will never be disclosed in any publicly-released reports. Information that identifies you or your child personally (name, birth date, address) is seen only in limited circumstances by select staff of your early care and education program, city funding departments, and contractors hired by the city to protect, store, and analyze data and improve the quality of programs.

Our data policy is **NOT TO SHARE** information with private corporations or marketing firms, or collection and credit agencies. We also **WILL NOT SHARE** your data with criminal justice, family courts, Immigration and Customs Enforcement, IRS, DMV, unless given a specific legal mandate to do so.

All kindergarteners in the San Francisco Unified School District (SFUSD) are given a basic skills assessment called the Kindergarten Readiness Inventory (KRI) at the beginning of the school year. If your child enrolls in SFUSD, we ask that you allow the school district to share your child's **attendance and KRI records** with DEC to improve the programs we offer to San Francisco families.
